

(c) if the answer to part (a) of the question be in negative, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (PROF. SHER SINGH): (a) and (b) The D.M.S. is at present supplying 3 lakh litres of milk daily utilizing 100% of its installed capacity. The installed capacity is being increased to 3.75 lakh litres daily to enable it to distribute a larger quantity of milk in the city. Although several cases of tampering of seals have been reported in the past, it would not be correct to state that there is large scale tampering with the seals on the D.M.S. milk bottles, 5.80 lakh of which are distributed daily. A major step taken recently to counteract such tampering was to confine the general distribution of the D.M.S. to only one kind of milk, namely, Special Toned Milk. The double Toned Milk supplied by the D.M.S. is distributed to relatively lower income groups in specific areas. To further reduce the possibility of malpractices at the D.M.S. booths, it is proposed to constitute Depot Advisory Committees comprising of the representatives of the token holders and to associate them with the smooth and fair distribution of milk from these depots. Zonal offices of the D.M.S. will also be opened for hearing the grievances of the customers.

The D.M.S. has been authorised to pay a higher price for the raw milk procured in the effort to collect larger quantities of fresh milk. The State Governments concerned with the D.M.S. milk-shed areas have also been requested to make specific arrangements for the supply of fresh milk to D.M.S. under their own supervision.
