(b and (c) Keeping in view the overall availability of foodgrains in the Central Pool and relative overall needs of deficit States. maximum possible quantities of foodgrains were supplied to Kerala State from the Central Pool to meet the reasonable requirements of the public distribution system in the State. The State Government was also authorised to purchase some quantity of rice on State to State basis from the surplus States, to supplement the Central supplies.

## Weedicides

- (a) whether Government have finalised plans to provide weedicides for the 1973-74 rabi campaign; and •
  - (b) if so, the details thereof?

THE MINISTER OF STATE IN HE MINISTRY OF AGRICUL-THE MINISTRY TURE (SHRI ANNASAHEB P. SHINDE): (a) and (b) While reviewing the Rabi 1973-74 programmes, the Government of India have brought to the attention of the State Government the need for effective weed control operations, especially with a view to reduce the loss of fertiliser consumed by weeds. In consultation with the State Governments, it had been decided to intensify extension efforts for effective weed control measures in selected The districts. Government India have organised short training courses for State Plant Protection Officers, in the proper application of chemical weedicides and precautions to be taken in such applications. The State Governments were also requested to ensure more credit inflow to the farmers for obtaining weedicides. The pesticide industry had also agreed to organise demon-stration campaigns in coordination with such campaigns taken up by the State and Central Governments.
