Cattle Camps in Maharashtra

238. DR. KUMARI SAROJINI KRISHNARAO BABAR: Will the Minister of AGRICULTURE be pleased to state:

- (a) the number of Cattle camps so far opened in drought hit areas of Maharashtra, Gujarat and Rajasthan;
- (b) how many were run in a Private Sector and how many subsidised by Government; and
- (c) whether it is a fact that farmers were compelled to sell their Cattle to these camps?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (PRCF SHER SINGH): (a) to (c) 156 cattle camps were opened drought hit areas of Maharashtra in 1972-73, 19 camps were set up by nonofficial agencies without any subsidy from State Government. The State Government provided Rs. 50,000 per district for construction of cattlesheds, water troughs and employment of managers, besides Rs. 2.50 per day per cattle during their period of stay in the camps. The remaining camps were opened by official agencies. No case of farmers compelled to sell their cattle to these camps came to the notice of the State Government. The information in regard to Gujarat and Rajasthan is being collected and will be laid on the Table of the Sabha in due course.
