## Foreign Tours of Journalists and Representatives from News Agencies

Will the, Minister of INFORMATION AND BROADCASTING be pleased to refer to the reply to Unstarred Question No. 225 given in the Rajya Sabha on July 26, 1973 and state:

- (a) whether the journalists and repre sentatives from news agencies who ac companied the President of India during his foreign tour, mostly came from the Newspaper Organisations in Northern and Western India and not one journa lists belonging to any important Cal cutta newspaper was included in these visits; and
- (b) whether Government propose to include journalists from all over the country, by rotation, in such foreign tours of the President in future?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA): (a) Due to shortage of space in the aircraft, selection of journalists covering V.I.P. foreign tours is limited to representatives of news agencies who are requested to nominate. Only during the President's visit to Ceylon in 1970, representatives of two South Indian newspapers were included in the Press party.

(b) Limitation will not permit inclu sion of newspaper representatives.

- (c) what is the percentage of shortfall or increase in expenditure in respect of the various Schemes/Projects; and

## (d) the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA): (a) The Fourth Plan allocation in respect of schemes/projects concerning Ministry of Information and Broadcasting was Rs. 45 crores, comprising Rs. 40 crores for Broadcasting (Development) and T.V. and Rs. '5 crores for schemes/projects of the various Information and Publicity media of this Ministry.

(b) As the Fourth Plan period is not yet over it is premature to indicate final
