Retrenchments from defence units are made only when surpluses are found as a result of periodical reviews, reorganisation, disbandments, economy cuts, reduction in workload or similar other res-sons.

(b) Efforts are made to provide alternative jobs to the retrenched personnel either in equivalent posts or in lower posts to the extent possible.]

Project for the manufacture of Lambretta Scooters

372. SHRI M.B. SINGH: Will the Minister of HEAVY INDUSTRY be pleased to state the progress made so far in re gard to setting up of a proposed project in the public sector for the manufacture of Lambretta Scooter?

THE DEPUTY MINISTER IN THE MINISTRY OF HEAVY INDUSTRY (SHRI DALBIR SINGH): The construction of the factory buildings is in progress. The machine tools and equipment imported from the works of M/s INNOCENT!, Italy for the manufacture of two wheelers have been received at the site. Equipments for three wheelers are expected to be received in January, 1974. Production of twowheelers is likely to commence in August, 1974.
