(b) the number of tea gardens operating at present ?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI BAL GOVIND VERMA) : (a) and (b) Information is being collected.

**Indo-Pak Talks on Repatriation**

353. SHRI THILLAI VILLALAN : Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether officials of our country and Pakistan recently had a dialogue at Dacca to review the progress of the three-way repatriation under the Delhi agreement ; and

(b) if so, what are the details thereof ?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) An Indian official delegation had discussions with Bangladesh officials in Dacca on 26th and 27th October, 1973 to review the progress of the three-way repatriation under the Delhi Agreement.

(b) In view of the slow pace of repatriation of Pakistanis from Bangladesh, it was decided that Pakistan Government will be asked to accelerate the rate of clearances of its nationals in Bangladesh for repatriation to Pakistan.
