would like to know is what are the loss figures of the Wig India only for the last year's performance. Secondly, when you say that synthetic product is in competition with the natural hair, can you give us the comparative figures of exports from Korea and Taiwan of natural hair in the last three years as compared to the exports from India ? This would prove whether there is competition between the natural hair and the synthetic hair or is it because of the pricing that the Indian hair islosing market'!

SHRI A. C. GEORGE : Sir, loss in 1972-73 is Rs. 22 lakhs. About the second part of the hon'ble Member's question, namely, comparative figures of Korea, Taiwan and India, since this is a very specific question, I need notice.

MR. CHAIRMAN : Mr. Kulkarni. Short question.

SHRI A. G. KULKARNI : As usual I will ask a very short question. Sir, the point made by my colleague, Mrs. Kulkarni, has to be taken note of and, if the customers abroad are mainly ladies, the advice of lady talent available in the country has to be taken, because ladies require...

SHRIMATI SUMITRA G. KULKARNI : Not only ladies, men also wear it.

SHRI A. G. KULKARNI : I am coming to that part.

MR. CHAIRMAN : I do not want any discussion between the two hon. Members.

SHRI A. G. KULKARNI : The point is, it seems that the loss suffered by Wig India is due to bad business adver tising or bad designing of the products, etc. Competition from synthetic Products might also be there. But ladies naturally like the natural colour. And you have said that Rs. 7 crojes was the sales at one time ...... MR. CHAIRMAN : Kindly put your question.

SHRI A. G. KULKARNI: 1 am finishing. {Interruption) Why is Mr. Shyamlal Gupta standing : Why are yon in a hurry ?

SHRI SHYAMLAL GUPTA : The next question is more important than this question.

SHRI A. G. KULKARNI : It may be important to you. It is not important to me. It is all political stunt which you want to have. I am not interested in political stunts like you.

MR. CHAIRMAN : Kindly complete your question.

SHRI A. G. KULKARNI: I want to know from the Minister whether the talent, particularly lady talent, available in this country for aggressive salesmanship abroad will be utilised by the Ministry to boost the sales of the products of Wig India ?

SHRI A. C. GEORGE : Any suggestion feasible and worthwhile about aggressive salesmanship will be considered.

SHRI A. G. KUULKARNI : By ladies.
