**राज्य खाद्य निगम की स्थापना के लिये
मध्य प्रदेश को वित्तीय सहायता**

1557. श्री पंडरीनाथ सीतारामजी पाटिल: क्या कृषि मंत्री यह बताने की कृपा करेंगे कि:

(क) क्या मध्य प्रदेश सरकार ने गेहूँ, दालों और चावल के व्यापार को अपने हाथ में लेने और इन खाद्यान्तों का अन्तर्राज्यीय व्यापार आरम्भ करने की दृष्टि से राज्य खाद्य व्यापार निगम की स्थापना करने का निर्णय किया है और इस प्रयोजन के लिए केन्द्रीय सरकार से वित्तीय सहायता मांगी है ;

(ख) क्या केन्द्रीय सरकार ने चावल के व्यापार को अपने हाथ में लेने के लिए राज्य सरकार को मार्ग-दर्शक सिद्धान्त प्रेषित किए हैं; और

(ग) राज्य सरकार को वित्तीय सहायता देने के सम्बन्ध में केन्द्रीय सरकार की नीति क्या है ?

Financial assistance to M.P. for State Food Corporation

1557. SHRI P. S. PATIL: Will the Minister of AGRICULTURE be pleased to state:

fa) whether Madhya Pradesh Government have decided to take over wheat,

pulses and rice trade and set up a State Food Trading Corporation with a view to start inter-State trade of these foodgrains and have sought financial assistance from the Central Government for this purpose;

(b) whether the Central Government have sent guide-lines to the State Government for the take over of rice trade: and

(c) what is the policy of the Central Government in regard to advancing financial assistance to the State Government?]

कृषि मंत्रालय में राज्य मंत्री (श्री अण्णासाहेब शिन्दे): (क) मध्य प्रदेश सरकार ने खाद्य, सिविल सप्लाइज और आवश्यक जिन्यों का कारोबार करने के लिए समवाय अधिनियम के अधीन एक राज्य जिन्य निगम स्थापित करने की इच्छा व्यक्त की है और 25 करोड़ रुपये का एक ब्याज मुक्त ऋण मांगा है।

(ख) चावल का थोक व्यापार लेने के विभिन्न परिचालन सम्बन्धी पहलुओं पर सावधानी से विचार करने के बाद और चावल की पर्याप्त मात्रा को अधि-प्राप्ति करने की आवश्यकता पर विचार करते हुए यह निश्चय किया गया कि अधिप्राप्ति को प्रणाली अपनाने का कार्य राज्यों पर छोड़ दिया जाए, ताकि वे इस प्रयोजन के लिए सर्वोत्तम उपयुक्त प्रणाली अपना सकें। जो राज्य सरकारें 1973-74 खरीफ मौसम में चावल का थोक व्यापार अपने हाथ में लेने के इच्छुक हों, वे ऐसा कर सकती हैं।

(ग) समवाय अधिनियम के अधीन राज्य सरकारों को अपने निगम स्थापित करने के लिए वित्तीय सहायता देने की फिलहाल कोई योजना नहीं है।
