

(c) Government is already making all efforts to optimise the production and to streamline the distribution of fertilisers.

Maximising of Pn Auction

Every effort is being made to optimise production in the existing units. Additional production is also sought to be achieved by expeditious implementation of the projects under erection, by expansion of capacity of existing units, wherever possible, and by setting up new projects.

Steps Taken to Improve Distribution of Fertilisers:

A number of steps have been taken to improve the distribution of fertilisers. These are:

(i) Coordinated supply plans are being drawn up in the Zonal Conference before each crop season together with the representatives of the State Governments and of domestic manufacturers concerned. Orders under the Essential Commodities Act are issued thereafter, making it legally obligatory for the domestic manufacturers to supply the quantities of fertilisers committed by them to each State at the Conferences. The inter-state movement of fertilisers except for certain specified categories is also banned so as to ensure compliance with the distribution schemes.

(ii) In order to avoid long haulage and cross movement of fertilisers, a rationalised programme of distribution of Pool and domestically manufactured fertilisers is being followed.

(iii) The fertiliser manufacturers have been requested to channelise as much of their output as possible through cooperative and other public organisations.

(iv) Through monthly reviews at a very high level a careful watch is being kept on the availability of wagons for rail movement in order to ensure that distribution of fertilisers is not affected by bottlenecks in rail transport.
