THE DEPUTY MINISTRY IN THE MINISTRY OF INDUSTRIAL DEVE-LOPMENT (SHRI PRANAB MUKERJEE): (a) No, Sir. The total allocation of E.C. Grade aluminium to DGTD units for 1973-74 was 53539m. tonnes indigenous and 1364 m. tonnes imported.

(b) to (d) No, Sir. An allocation of 25,000 m. tonnes has been made by the Department of Mines for meeting the requirements of small scale units. The precise capacity on double shift basis of ACSR1ACC conductors has not been assessed. The question of increased allocation has been taken up.

As the material is released by producers directly to the orcduetion units on the recommendation of the competent authority, information as to the exact quantity that has been lifted by the various units in the large or small scale sectors is not available.
