## **Development of Metropolitan Cities**

## Statement

The strategy for the development of metropolitan cities in the context of Metropolitan Regional Planning has been indicated in successive Five Year Plan. Policies and measures have been suggested to reduce the pressure of population on such cities. Preparation and formulation of Metropolitan Regional Plans for specific areas and their implementation are however, the responsibility of the State Governments and of the local authorities concerned.

In the Draft Fifth Plan, a provision of Rs. 250 crores has been proposed in the Central sector for implementation of urban development projects of national importance. The provision would supplement the efforts of the State Governments and local bodies in implementing programmes relating to Metropolitan cities.
