

गृह मंत्रालय तथा कार्मिक विभाग व राज्य मंत्री (श्री राम निवास मिर्धा) : (क) और (ख) उत्तर प्रदेश सरकार से प्राप्त सूचना के अनुसार सैनिक वर्दी में एक व्यक्ति जो अपने को एम० आर० हसन कहता था, 18 अक्टूबर 1973 को इलाहाबाद में गिरफ्तार किया गया था। उसके विरुद्ध भारतीय दण्ड संहिता की धारा 140/146 के तथा भारत रत्न नियम 1971 के नियम 7/56/58 के अन्तर्गत एक मामला दर्ज किया गया है और जांच पड़ताल की जा रही है। अब तक की गई जांच पड़ताल में कोई आसूची दृष्टिकोण प्रकट नहीं हुआ है।

[THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND II THE DEPARTMENT OF PERSONNEL (SHRI RAM NIWAS MIRDHA): (a) and (b) According to information received from the Government of Uttar Pradesh, one person in army uniform calling himself as S. R. Hassan was arrested on 18th October 1973 in Allahabad. A case U/S 140/147 IPC and rule 7156158 of D.I.R. 1971 has been registered against him and investigation is in progress. No espionage angle has been disclosed in the investigations made so far.]

#### A.I.R. Station at Mangalore

(a) the progress made so far in respect of the setting up of a A.I.R. Station at Mangalore and transmitter at Brahmawar and

(b) The project is likely to be completed during 1975-76. However as the transmitter installation is likely to be completed before the studios are commissioned, it is proposed to relay programmes from Bangalore till the studios at Mangalore are commissioned.

(b) whether these memoranda have been submitted to the District Collector, I.G. (Vigilance), Orissa, and to the Government of Orissa six months back; and

(c) if so, what are the main allegations, and the steps taken by Government to have the matter investigated; and action taken thereon?

Petitions have been presented to the District Collector and the Director, Gram Panchayat, Orissa in respect of some donations received by the Chairman, Odapada Panchayat Samiti as Secretary of the Kharaga Prasad High School.
