Will the Minister of AGRICUL-TURE: be pleased to state:

- (a) whether Government's attention has been invited to a report published in the Indian Express dated 10th September, 1973, to the effect that India produces only half the quantity of its requirements of pulses;
- (b) whether the Central Government are planning to launch pulses cultivation programmes in several districts; and
- (c) if so, the details thereof and the extent to which cultivation of pulses will increase consequently?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) Yes, Sir; but it is not a fact that the production of pulses is half the quantity required as reported in the press, although it is not enough to meet the requirements of the country.

(b) Yes, Sir. The Central Government have initiated intensive pulses cultivation under the centrally sponsored scheme in kharif 1972.

- (c) Under this scheme central assistance as subsidy has been provided to the state governments for:
 - (i) laying out of extension demonstrations,
 - (ii) nucleus and foundation seed multiplication,
 - (iii) plant protection chemicals,
 - (iv) supply of seed of short duration and improved varieties of pulses, and
 - (v) equipping of the microbiological laboratories of the state Departments of Agri./Agricultural Universities for production of rhizobium culture for supply to the farmers. As a result of these efforts the production of pulses is expected to increase by one million tonnes during 1973-74.

W.H.O. On Malaria and Smallpox in \ India

519. SHRI SURAJ PRASAD: SHRI YOGENDRA SHARMA:

Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state:

- (a) whether it is a fact that the Chief of the World Health Organisation recently said that in India the programmes for eradication of malaria and smallpox had received setbacks;
 - (b) if so, the details thereof; and
- (c) what is the number of persons who were affected by smallpox and malaria in 1971-72 and 1972-73?

THE DEPUTY MINISTER OF HEALTH AND FAMILY PLANING (PROF. A. K. KISKU): (a) and (b) It has been indicated in the Annual Report of the Regional Director, World Health Organisation for South East Asia for the year 1972-73 that there had been numerous setbacks to the antimalaria programme in India and that there had been a steady increase in the number of malaria cases occurring in major towns. It has also been mentioned that efforts to control urban malaria

had been considerably increased and that in the pilot project at Jodhpur ultralow-volume techniques of insecticide spraying had been continued and the results of early experiments had been encouraging.

Regarding smallpox, it has been indicated in the same report that there had been an increase in the number of cases reported in India and that major epidemics had occurred in the highly endemic northern States. It has also been mentioned that efforts were concentrated on preventing the spread of infection and on controlling epidemics in the most highly infected regions and that by June 1973 some improvement in the situation had been registered.
