Chairman, Atomic Energy Commission stressed the need for restructuring the system, particularly educational scientific and technological programmes.

In the Fifth Five Year Plan, the Gov. ernment proposes to make an intensive effort to reconstruct the educational system in the country keeping in view the social, economic and industrial needs of the country. Science Education and Technical Education including research in science and technology are proposed to be emphasised in this programme. A draft plan of education has, accordingly, been prepared and is under consideration of the Planning Commission.

(b) 13 cases were reported to have developed symptoms of food poisoning in village Sarai (Juliana) near Okhla after taking sweets from a shop in that village on the eve of Diwali. Only 2 cases were treated in the Holy Family Hospital as indoor patients. All the persons recovered. The samples of sweets taken were analysed but no positive organism of food poisoning was detected
