THE MINISTER OF HOME AFFAIRS (SHRI UMASHANKAR DIKSHIT) : (a) Yes, Sir.

(b) Legislative proposals are being finalised and a Bill in this regard will be introduced in Parliament shortly.

#### Direct contact between the Cabinet Secretariat and the Secretaries to Various Ministers

(a) whether it is a fact that the Cabinet Secretariat has established direct contacts with the Secretaries of various Ministries by-passing the Ministers concerned; and

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI) : (a) and (b) Consultations between the various Ministries and the Cabinet Secretariat are held at different levels. For important matters there are Committees of Secretaries over which the Cabinet Secretary presides. However, final decisions are taken by the Government. The question of Cabinet Secretariat by-passing the Ministers does not arise.
