Licence to Calcutta factory of Philips Radio

607. SHRI NIREN GHOSH : Will the Minister of ELECTRONICS be pleased to state :

(a) whether it is a fact that Government insisted on compliance of the export guarantee licence by M/s. Philips & Co. for grant of licence for extending its Calcutta factory ; and

(b) if so, the reasons thereof ?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI) : (a) Yes, Sir.

(b) The application of M/s. Philips India for the expansion of Radio production at their Calcutta factory was received on 21-4-1969. It was considered by the Licensing Committee on 8-6-1970, wherein it was decided that the expansion could be agreed to provided the company under-took an export obligation of 75 per cent. This was in accordance with the policy of the Government of India in force at that time which stipulated that large houses and companies with foreign equity majority may not be allowed to enter certain areas in which the small scale industry has a vital interest, unless a 75 per cent export obligation were imposed in such cases. The decision of the Licensing Committee was intimated to M/s. Philips India on 22-9-70 and the company has represented against the decision. In December, 1971, the company has again been informed by the Government that the earlier decision to impose the export obligation would stand.
