

(iv) inculcating in the minds of the youth the concept of national unity in a secular State.

Research and educational institutions are also being aided through financial grants for conduct of research projects on subjects which might lead to a better understanding of the problems relating to national integration.

(b) Under the Central Government scheme of financial assistance to Voluntary Organisations for promotions of Hindi, the Dakshin Bharat Hindi Prachar Sabha and 4 other such Voluntary Organisations are running 91 full time Vidyalayas and 133 part-time classes for teaching Hindi to those who desire to learn the language voluntarily in Tamil Nadu. This assistance is proposed to be continued during the Fifth Five Year Plan also. Besides, the people of Tamil Nadu can avail of the facilities for learning Hindi provided under the Correspondence Courses in Hindi by the Central Hindi Directorate. These facilities are likely to be continued on expanded scale in the Fifth Five Year Plan.]
