

**Raid by Income-tax Authorities at the premises of an arms dealer of Kanpur**

\*328. **SHRI NIREN GHOSH:** Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that the income-tax authorities recently raided the business premises of an arms dealer at Kanpur and seized documents relating to unaccounted transactions involving arms and ammunition worth several lakhs of rupees;

(b) if so, what are the details thereof; and

(c) what action has been taken by Government against the arms dealer?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (**SHRI K. R. GANESH**): (a) to (c) There was no such raid by the Income-tax authorities. However, in connection with some pending Wealth-tax proceedings the Income-Tax Officer visited the business premises of M/s Yadav Arms Company, Kanpur under section 133A of the Income-tax Act, 1961. Books of accounts were examined. In order to facilitate the examination, the assessee voluntarily brought the books of account to the Income-tax office. A detailed examination of the books of accounts is in progress.

**Facilities for Employees in Public Undertakings**

of their counter-parts in the Central Government, taking into account all the components of emoluments, e.g. pay, dearness allowance, housing/house rent allowance, conveyance allowance, etc.

**Gold and cash recovered from the house of Head Cashier of Vijayanagram branch of S. B. I.**

(a) whether it is a fact that huge quantity of gold and some cash had recently been recovered from the house of the Head Cashier of the Vijayanagram branch of the State Bank of India;

(b) if so, what are the details thereof; and

(c) what action has been taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI K. R. GANESH): (a) to (c) Yes, Sir. On a search of the family residence of Shri K. Hanumantha Rao, Chief Cashier of the Vijayanagram branch of the State Bank of India and his brothers by the Central Excise Officers on the 13th and 14th September 1973, primary gold weighing 276 grammes and gold ornaments weighing 9284 grammes were seized for contravention of the Gold (Control) Act. The Income-tax officers also recovered rupees 37,500 in cash and some papers. The Special Police Establishment, Hyderabad have registered a case against Shri Hanumantha Rao. The cases are under investigation.
