The Voluntary Organisations/educational institutions, which are registered under the Societies Registration Act 1860 or the Charitable Endowment; Act, 1890 or registered under the Co-operative Societies Registration Act prevalent in the State for the time being, or anj other similar organisations are eligible foi grant under the scheme. The scheme i< advertised in the important newspaper every year and applications for flnancia assistance received through the respectiv< State Governments are considered.

Government have also another schemi for editing and publication of rare manu scripts in Sanskrit, Pali, Prakrit, Arabi and Persian under which financial assis tance is given to registered institutions o institutions maintained by Government o Government bodies excluding thos affiliated or maintained by universities which are engaged in the editing and put lication of rare manuscripts in the countri Financial assistance is given upto 50 pe cent of the expenditure involved. Befor starting the work each institution is n quired to settle with the Board of Editoi set up by Government the lines on whic the work is to be carried out. The inst:
