# Vishakhapatnam Port

- 818. SHRI SITARAM KESRI: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:
- (a) whether it is a fact that the Central Road Research Institute has objected to the stocking of iron ore at Vishakhapatnam Port beyond a height of 2.5 metres: and
- (b) if so, the reaction of Government thereto?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMLAPATI TRI-PATHI): (a) and (b) For iron ore shipment through the existing West Ore Berth ir Inner Harbour, Visakhapatnam, ore stocking was gradually raised to 5 metres by 1967 when sub-soil failure took place. The Central Road Research Institute who were approached in 1968 for advice in the matter, advised restrictions in heights varying from 2.5 to 4.5 metres. also opined that further raising of heights could be considered after 1972. The existing stockpile capacity of 3 lakh tonnes is considered sufficient for the throughput of 6 million tonnes per annum. No further soil investigation to increase the present stockpile heights is considered necessary.

Capacity of ore dumps is, however, being increased for the Outer Harbour and the adjacent areas are being artificially

consolidated. Additional stocking capacity will be 3 lakh tonnes in 1974 with initial loading height of 2.5 metres which will be increased to 4.5 metres finally in 1980, resulting in additional capacity of 5 lakh tonnes making the total capacity of 8 lakh tonnes.

## Production of Foodgrains during Rabi Season

819. SHRI LOKANATH MISRA: SHRI DEBANANDA AMAT: SHRI K. P. SINGH DEO: SHRI K. C. PANDA:

Will the Minister of AGRICULTURE be pleased to state:

- (a) the production of foodgrains during the current Rabi season;
- (b) whether foodgrains supply position in the country has improved and if so, to what extent; and
- (c) if not, what efforts are being made by Government to ensure adequate food supply in the country?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) to (c) A statement is attached.

#### Statement

- (a) and (b) The total output of rab foodgrains during 1972-73 crop season is reported to be lower than the previous year and is estimated to be around 379.72 lakh tonnes.
- (c) To ensure adequate food supplies is the country and also to improve availabi lity of foodgrains, the following steps hav been taker by the Government:
  - (1) Country-wide special efforts t raise the production of Kharif crop b increasing the area under high-yieldin variety, promotion of effective utilisatio of irrigation potential and balanced us of fertilizers and timely provision credit.

- (2) Increase in the procurement prices of kharif cereals and increase in the support prices of wheat as incentive for increased production and procurement.
- (3) Import of limited quantity of foodgrains.
- (4) Acceptance of the loan of 2 million tonnes of wheat from the U.S.S.R. Government.
- (5) Effective implementation of regulatory laws.
- food-(6) Curbs on consumption of grains by strict enforcement of Guest Control Orders.

# Procurement Price of Paddy

820. SHRI K. C. PANDA: SHRI LOKANATH MISRA: SHRI DEBANANDA AMAT: SHRI M. K. MOHTA:

Will the Minister of AGRICULTURE be pleased to state:

- (a) the difference between the procurement price suggested by the Agricultural Prices Commission and the cost of production of paddy, separately on the basis of paid out costs and on input costs of family labour, rent and interest; and
- (b) whether there has been an increase in wages proportionate to the rise in the cost of paddy, if so to what extent?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) and (b) Representative estimates of cost of production of paddy for different States, with detailed input-wise break-up, are not yet available. However, while recommending the procurement price for 1973-74 season, the Agricultural Prices Commission obtained the estimates of cost of production Governments, of paddy from the State which were found by it to converge, by and large, within the range of Rs. 50 to Rs. 55 per quintal and took into account recommended a procurement price of Rs. 63 per quintal for standard variety of paddy. As regards increase in wages proportionate to the rise in the cost of paddy, no such precise relationship can be established.

# Setting up of Food Corporations by the States

SHINDE): (a) and (b) In the context of the need to assume greater responsibility by the State Governments in the procurement and distribution of foodgrains and other essential commodities, the Central Government as such would have no objection to the setting up of separate Corporations/Undertakings by the State Governments, provided there was agreement regarding the supply to the Central Pool the contribution expected of them and absorption of the employees of the Food Corporation of India that would be rendered surplus in the process.
