Delhi University Medical College Plan

488. SHRIMATI SAVITA BEHEN : Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state :

(a) whether it is a fact that Executive Council of Delhi University has expressed its disapproval of the Government's proposal to wind up the Delhi University Medical College Plan, and to start a new college affiliated to Nehru University in South Delhi; and

(b) if so, what is the precise proposal of Government in this regard and Government's reaction to Executive Council's view in this regard?

THE DEPUTY MINISTER IN THE
MINISTRY OF HEALTH AND FAMILY
PLANNING (PROF. A. K. KISKU): (a) It is not correct that the Government had a proposal to wind up the Delhi University Medical College Plan. However, the Academic Council has passed a resolution stating that the University Medical College should continue to be run under the auspices of the Delhi University and all possible steps should be taken to expedite the construction of hospital-cum-medical college complex at Shahdara.

(b) The medical college was opened in the campus of the Delhi University in 1971 with the intention of locating it later at Shahdara, utilising the facilities of a Hospital proposed to be constructed at that place. It has not yet been possible to get land in a single compact block to locate the medical college-CHM-hospital complex. Meanwhile, the first batches of students have to be given clinical training from the current year. In the interests of medical education of the students, other possibilities of expediting the setting up of a college are under examination. The views expressed by the Executive Council of the Delhi University would be taken into consideration before a final decision is taken.

Delhi Transport Corporation
