STATEMENT

In September, 1972, the Calcutta Metropolitan Development Authority took a decision for developing quarries at Indrabil in the district of Purulia (West Bengal). But subsequently the Government of West Bengal decided that the development of quarries would be done by the West Bengal Mineral Development and Trading Corporation.

Railway Authorities were requested to conduct a detailed survey of the area for affording railway siding facility for rake movement in Indrabil area where the quarries are proposed to be developed. The survey report from the Railways is awaited.
