in the country as a whole due to the severe power cuts, strikes in some factories, inadequacy of coal, water etc. It is, therefore, not improbable that construction work including Government works, had been affected to some extent.

- (b) The monthly requirement of the Delhi Slate is about 65,000 tonnes and supplies during the months of April, May and June 1973 were 36.000, 36,000 and 49.000 tonnes respectively. To ensure equitable distribution of available supplies. the Delhi Administration issued an order under the Essential Commodities Act on 12th July. 1972 to control sale of cement by stockists and introduced permit system with effect from 16th November, 1972 under which 90°A of stocks of cement are sold by the stockists against permits issued by the Delhi Administration and remaining 16% is so'd without permits to consumers reauiring cement up to 5 bags on first-come served basis.
- fc) Supplies ranging from 50,000 to 55.000 tonnes per month have been programmed during the next three months in addition to about 12.000 tonnes per month to meet the requirements of the Central Government Departments. This will improve the supply position in Delhi.

The total plan outlay for 1973-74 in respect of Mysore has been fixed at Rs. 82.37 crores, out of which the Central assistance would amount to
