#### **Vacant posts of Joint Director (OL)**

2329. SHRI DHARAM PAL SABHARWAL: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that 6 out of 20 posts of Joint Director (OL) are lying vacant since long;

(b) if so, what are the reasons that the meeting of DPC has not been convened for the purpose; and

(c) by when Government propose to convene the DPC to fill the vacant posts of Joint Director (OL)?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MANIKRAO HODLYA GAVIT): (a) Six posts of Joint Director (OL) are lying vacant from different dates in different Ministries/Departments.

(b) and (c) Promotion to the posts of Joint Director (OL) is made on the recommendation of Departmental Promotion Committee (DPC) convened by Union Public Service Commission (UPSC). The proposal for holding DPC meeting was sent to UPSC on 25.5.2004, and regular reminders are being sent to UPSC in this regard. However, keeping in view the urgency, orders for filling up these six posts of Joint Director (OL) on *ad-hoc* basis have been issued *vide* orders dated 4.3.2005 and 18.3.2005.

**Proposal submitted by Maharashtra Government to APEDA**

(a) whether it is a fact that Government of Maharashtra have submitted a proposal to APEDA regarding accreditation of the State seeds certification agency for organic farming;

Certain non-conformities found in the application were conveyed to the State Government, which has now submitted a revised application for evaluation by APEDA.
