THE MINISTER OF HEAVY INDUS TRY (SHRI T A PAI) (a) and (b) While this Ministry has not received any proposal from the West Bengal Government for setting up a public sector unit in the State for the manufacture of large size transformers, a proposal received from the West Bengal Industrial Development Corpora tion for setting up a scooter factory has been already considered and a Letter of Intent granted for setting up a capacity of 30,000 scooters per annum

As for a large antibiotic factory, it is learnt from the Ministry of Petroleum and Chemicals which is the concerned Ministry that they have not received any concrete proposal for setting up such a unit in the Public Sector in the State

Western Naval Presence in Indian Ocean

(b) The North Atlantic Assembly is an organisation of Parliamentarians from NATO countries but is not an organ of the NATO Its recommendations are not binding on the NATO Government's view that the Indian Ocean should be an area of peace, free from great Power presence rivalries and tensions, is well known

Educational tacilities to children of Armed Forces personnel

Statement

Education is a State subject and each State is free to frame its own rules on matters regarding education the following educational concessions are available from the Central Government to the children of Armed Forces person-

1 OFFICERS

The Army Officers Contributory Eduation Fund, The Naval Officers Contributory Education Scheme and the Air Force Officers Contributory Education Fund render assistance by awarding scholarships to children of Service Officers only

Subscription is collected from a Service Officer which is Rs 18 per quarter in the Army, Rs 15 per quarter in the Navy and Rs 10 per quarter in the Air Force

The benefits derived by the Members of Funds are as under

Short supply of coal to cement industry in Andhra Pradesh

- (b) whether it is also a fact that one unit producing about 250 tonnes of cement a day had been closed down on the 13th May, 1973, and

THE MINISTER OF STEEL AND MINES (SHRI T A. PAI). (a) and (b) There have been complaints from cement factories, including those in Andhra Pradesh, that they are facing shortage of coal supplies and have to operate with very low levels of coal stocks The Government has, however, received no report that any factory actually closed down on account of shortage of coal

(c) With a view to supplying the coal required by each of the cement factory in full, the Standing Linkage Committee has linked the factories with the coalfields in a rational manner This is expected to improve the position progressively
