

**K. G. R. I. M. Type Military Schools**

\*437. SHRI K. B. CHETTRI: Will the Minister of DEFENCE be pleased to state:

(a) the number of Sainik Schools and the Military Schools of King George Royal Indian Military type in the country:

(b) whether it is a fact that Government have proposed to open a Military school of this type in the Eastern Region specially in the hill district of Darjeeling; and

(c) if so, the details thereof.

THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM): (a) There are 17 Sainik Schools, 5 Military Schools and one Rashtriya Indian Military College located at Dehradun. (b) and (c) There is no such proposal under consideration.

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) Government have seen press reports of President Bhutto's statement to this effect.

fb) Some of the negative statements made recently by Pakistan leaders were brought to the notice of the Pakistan Government during the recent negotiations between the Special Emissaries of the two countries. It was, however, not considered necessary to seek any clarifications. These talks were held to consider the resolution of the humanitarian issues arising out of the 1971 Conflict, on the basis of the Joint Tndo-Bangladesh Declaration of the 17th of April. 1973.
