THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR AND REHA-G. VENKAT BILITATION (SHRI SWAMY): (a) The wages of workers in the coai, iron ore, limestone and dolomite mines were payable in terms of the recommendations of the Wage Boards. The Wage Boards are, however, not statutory bodies and the wage rates were not enforceable statutorily.

Wages of workers in gypsum, bauxite, barytes and manganese mines were fixed under the Minimum Wages Act, 1948, on the 19th May. 1969. The rate of unskilled workers was fixed at Rs. 2.40 per day in manganese and barytes mines and at Rs. 2.60 per day in bauxite and gypsum mines. These have since been revised to Rs. 4.00 per day for the four classes of mines wilh effect from 17th July. 1973. These are enforced by Central Industrial Relations machinery.

fb) Employers paying wages less than those notified under the Minimum Wages Act, 1948 and violating other provisions of the Act and Rules, are liable to legal action/prosecution under the Act.

## Repatriating of Sick P.O.Ws.

888. SHRI GANESH LAL MALI:

SHRIMATI PRATIBHA SINGH:

Will the Minister of DEFENCE be pleased to state the number of sick Pakistani POWs who have so far been repatriated to Pakistan, and the number of Indian and Bangladesh internees who have been returned by Pakistan in exchange thereof?

THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM): 1047 sick and wounded Pakistani Prisoners of War have so far been repatriated to Pakistan. The sick and wounded Prisoners of War are repatriated not on exchange basis but on humanitarian considerations. Therefore, the question of exchange of Pakistani Prisoners of War on the one hand and the Indian and Bangladesh internees on the other, does not arise. However. 33 Indian prisoners of war and 20 Ban gal i Army men have been repatriated in the category of sick and wounded personnel.
