the production of mass consumption goods only if special factors exist such as sizeable economies of scale resulting in reduced prices, technological improvements, large investment requirements, substantial export possibilities or as a part of modernisation.

Fertilizer Factory

1754. SHRI P. K. KUNJACHEN: SHRI K. P. SUBRAMANIA MENON:

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether Government have decided to start 12 new fertilizer factories:
- (b) if so, the names of the places where the factories are going to be established?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH): (a) and (b) Government have approved in principle the setting up of 5 new fertilizer plants in the public sector during the Fifth Plan. These plants will be located at Mathura (Uttar Pradesh), Bhatinda (Punjab), Panipat (Haryana), Paradeep (Orissa) and Trombay (Maharashtra). In addition, a few plants are likely to be set up in the private sector for which proposals have been received.
