## Expenditure incurred on C.R.P. and D.S.E. during Andhra Pradesh Agitation

**\*499.** SHRI PAPI REDDI: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the expenditure incurred on C.R.P., Array and B.S.F. during the agitation in Andhra so far from last November; and
- (b) whether the expenditure is wholly met by the State Exchequer or shared by the Central Government also?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K. C PANT): (a) The following amounts have been spent on Central forces deployed in Andhra Pradesh:

- (i) *CRP*: Rs. 2,85,28,500 for the period 1-11-72 to 30-6-73. This does not include some minor running expenditure on Motor Transport for 3 months.
- (ii) *BSF*: Rs. 23,70,000 approximately for the period 23-11-72 to 30-3-73 by which date all units of BSF were withdrawn from the State.
- (iii) As no recoveries are to be made from the State Governments/ Union Territories Administration, on account of deployment of Army Units, the expenditure figures relating to the Army are not readily available.
- (b) In the case of the Army no recoveries have to be made from the Government of Andhra Pradesh according to the existing rules. In the case of CRP and BSF the full cost of deployment is recoverable from the State Government.
