- (b) Karaikal is adequately covered by the existing mediumwave Station at Tiruchi. We have no proposal therefore to set up a relay station at Karaikal.
- (c) Yes, Sir. The Programme Advisory Committees of various stations, including that of Pondicherry, are, however, being reconstituted.
- (d) Fifth Plan proposals for expansion of TV are under consideration of the Planning Commission.
- (e) This was considered but the proposal was not found feasible as the number of French-knowing people in Pondicherry is not substantial.

## Manufacture of consumer goods

SHRI Y. M. MAKWANA: Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state:

- (a) whether Government propose to set up units of Consumer goods production; and
  - (b) if so, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF **INDUSTRIAL** (SHRI DEVELOPMENT **PRANAB** MUKHERJEE): (a) It is one of Government's objectives to expand and extend the role of the public sector into new fields, including production of mass consumption goods in which significant production gaps are likely to develop in the future.

(b) Proposals for the manufacture of some consumer goods like Electric lamps, Tyres and Tubes in the public sector are under consideration and feasibility reports for some of these items have been prepared/are under preparation. However, the process of final selection of the consumer industries to be taken up in public sector has not been completed so far.
