

of the target fixed for them and made over to the Central Pool upto the 31st August 1971 is indicated below

(i) For the quantity procured upto 25% of the target fixed for the State and made over to the Central Pool—Rs. 5.00 bonus

(ii) For the quantity procured between 25% and upto 50% of the target and made over to the Central Pool—Rs. 10.00 per quintal

(iii) For the quantity procured above 50% but below 75% of the target and made over to the Central Pool—Rs. 5.00 per quintal.

(iv) For the quantity procured above 75% and upto 100% of the target and made over to the Central Pool—Rs. 7.00 per quintal

(v) For the quantity procured over and above the target fixed for the State and made over to the Central Pool—Rs. 10.00 per quintal

While communicating the details, the State Governments have been advised that the bonus earned should not be credited to the general revenue but utilised for increasing agricultural production by subsidizing the price of agricultural inputs like fertilizers etc. to the farmers. The details of the scheme have been left to the State Governments to work out.
