#### S.T.D. LINKING OF GURGAON AND DELHI

(b) if so, the main difficulties in this regard;

(c) by when S.T.D. system will be introduced between Delhi and Gurgaon?

THE MINISTER OF COMMUNICATIONS (SHRI H. N. BAHUGUNA) : (a) No, Sir. Gurgaon and Delhi are not connected with direct dialling system at present.

(b) Subscriber trunk dialling equipment is under installation and testing.

(c) The direct dialling system on this route (between Delhi and Gurgaon) is expected to be introduced by October 1973, if the system functioning tests are satisfactory.

Will the PRIME MINISTER be pleased to state:

(a) whether Government are considering to constitute All India Services for Engineering and Medicine;

(b) if so, when these are likely to be formed;

(c) what other All India Services are also contemplated; and

(d) whether it is also a fact that some State Governments are resisting the constitution of such All India Services?

THE MINISTER OF STATE IN THE DEPARTMENT OF PERSONNEL (SHRI RAM NIWAS MIRDHA): (a) to (d) A statement is laid on the Table of the House.

#### STATEMENT

The All India Services Act, 1951 (61 of 1951) was amended in 1963 to provide for the creation of the Indian Forest Service, the Indian Medical and Health Service, and the Indian Service of Engineers. The Indian Forest Service has since been constituted with effect from 1st July, 1966 and all the State Governments are participating in the Service. The position about the other services is as follows:—

#### Indian Service of Engineers :

The Indian Medical and Health Service was constituted with effect from 1st February, 1969 and formal orders were issued under Section 2A of the All India Services Act, 1951. However, no action has been taken so far either to constitute the State Cadres of the Service or to make initial recruitment thereto because seven State Governments viz, Tamil Nadu, Mysore, Punjab, West Bengal, Maharashtra, Jammu & Kashmir and Assam which had earlier agreed to participate in the Service subsequently either withdrew their consent to participate in the Service or expressed certain reservations regarding the need for the formation of the Service. The Ministry of Health and Family Planning (Department of Health) are pursuing the matter with these State Governments with a view to persuading them to reconsider the matter and participate in the Service. Position will be reviewed after replies from these State

Governments have been received by Government.

*Indian Service of Engineers :*

No formal orders constituting the Service have so far been issued because the Governments of Tamil Nadu, West Bengal, Assam, Jammu & Kashmir, Himachal Pradesh and Kerala, which had earlier agreed to participate in the proposed Service, have revised their stand and have stated that they do not want to participate in the Service. The matter has been taken up with these State Governments requesting them to reconsider the question and to agree to participate in the proposed Service. The position will be reviewed after replies from these State Governments have been received.

The Government do not contemplate constituting any other new All India Service.

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY (SHRI C. SUBRAMANIAM): (a) Yes Sir.
