(c) Yes, 'Channa' (commonly known as cheese) is prepared in large quantities in West Bengal, Bihar and Orissa for manufacture of sweets.

(d) The exact quantity is not known. The 'Channa' whey goes to waste as it is not possible to utilise it for manufacture of lactose.

(e) Sugar of milk (lactose) can be manufactured from whey. However, it is not possible to collect small quantities of 'Channa' whey from individual sweetmeat dealers from a limited area for manufacture of lactose. This whey needs to be chilled immediately to prevent fermentation and conversion of milk sugar (lactose) in whey to lactic acid. A lactose plant needs very large quantities of whey for manufacture of lactose.

### Jawaharlal Nehru University

1335. SHRI D. K. PATEL : Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state :

(a) whether the Jawaharlal Nehru University has taken over Institute of Russian Studies and Indian School of International Studies if so, from which dates; and

(b) whether Government have protected the service conditions of the non-teaching employees of the University enjoyed by them before take over of the above two institutions?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN) : (a) The Indian Institute of International Studies and the Institute of Russian Studies have been merged with the Jawaharlal Nehru University with effect from 5-6-1970 and 11-10-1969 respectively.

(b) According to the University, the service conditions of the non-teaching employees of both these institutions have been protected.
