#### Slavery in the Country

Will the Minister of HOME AFFAIRS be pleased to state the name of places or areas in the country where the system of bonded labour which is a form of slavery, is rampant?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND IN THE DEPARTMENT OF PERSONNEL (SHRI RAM NIWAS MIRDHA) : The general label "bonded labour" appears to have been applied loosely to various types of labour contracts which agricultural labour enters into with land owners for the purpose of repayment of debt due to them. According to the Commissioner for Scheduled Castes and Scheduled Tribes in India, in varying forms and degrees and under different names in some parts of Andhra Pradesh, Bihar, Gujarat, Kerala, Madhya Pradesh, Maharashtra, Mysore, Orissa, Rajasthan, Uttar Pradesh, Jammu and Kashmir and in Dadra and Nagar Haveli. This undesirable practice is dying out gradually due to general awareness among the backward people and due to the positive steps taken by various State Governments. The problem

is being tackled on a multi-pronged basis through legislation, land reforms and programmes of economic development.
