ATTACK ON THE INDIAN AIRLINES OFFICE AT KABUL BY SOME GUNMEN OF PAKISTANI ORIGIN

SHRIMATI SITA DEVI (Punjab): Sir, I call the attention of the Minister of Tourism and Civil Aviation to the attack on the Indian Airlines Office at Kabul on the 1st May, 1973, by some gunmen of Pakistani origin.

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (DR. (SMT.) **SAROJINI** MAHISHI): Sir, a serious incident occurred in Kabul on the 1st May at about 6 P.M. According to our latest information, a person entered the Indian Airlines office and directed the Chief Traffic Assistant Shri M.S. Sajwan, who was on duty to stand up. The intruder whipped out a revolver and fired a shot at the Chief Traffic Assistant which fortunately missed him. The Chief Traffic Assistant, displaying considerable courage and presence of mind,
