t[THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB SHINDE): (a) The per quintal cost of production of wheat reported by the Pantnagar Agricultural University ranged between Rs. 60 and Rs. 65; the Ludhiana Agricultural University Experts reported Rs. 76.95. The cost of production reported by these two Universities is higher than the cost estimated under the comprehensive scheme for studying the cost of cultivation of principal crops in Punjab, Haryana and U.P.

(b) The procurement prices of wheat have been fixed by the Government, on the basis of the recommendations of the Agricultural Prices Commission, as under:

THE MINISTER OF STATE IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS AND IN THE MINISTRY OF WORKS AND HOUSING (SHRI OM MEHTA): (a) The water supply is a State Sector Programme. During the IV Plan assistance is being given to the State Governments on the pattern of block loan and block grants 70 per cent and 30 per cent respectively on the basis of State Plan provisions for all development heads including water supply without any reference to head of development of any particular scheme. The Government of Tamil Nadu have incurred the following expenditure on Water Supply Schemes during 1971-72 and 1972-73:
