t[THE PRIME MINISTER (SHR1MATI INDIRA GANDHI): (a) Presently, the Tarapur Atomic Power Station is the only atomic power station under operation. It consists of two units of 210 MW each and has, upto the end of March, 1973, produced about 6078 million units of electrical energy. The first unit of the Rajasthan Atomic Power Project, which has a capacity of 200 MWe, attained critical ity on 11-8-72 and was synchronised to the grid on 30th November, 1972. It has since been producing power intermittently.

- (b) Apart from the production of electricity, atomic energy has found extensive peaceful applications in the fields of agriculture, biology, medicine and industry. Details of these are given in the Annual Reports of the Department of Atomic Energy which are circulated to the Hon'ble Members and copies of which are available in the Parliament Library.
- (c) and (d) India has power projects collaboration agreements with USA and Canada and bilateral agreements for collaboration in the field of peaceful uses of atomic energy with many countries which include some developed countries also. These are: Afghanistan, Belgium, Brazil, Czechoslovakia, Arab, Republic of Egypt, France, Federal Republic of Germany, Hungary, Philippines, Romania, Spain and USSR. Collaboration proposals with other advanced countries are not envisaged in the near future.]

  - (d) Government's reaction thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) Yes.

- (b) On 15-3-73, a D.T.C. bus stopped at Wazirabad Road Bus Stop. The students already in the bus objected to other persons boarding the bus. In the resulting dispute, two persons were stabbed.
- (c) No. There has been some increase in the registration of crime.
  - (d) Does not arise.
