THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) The first unit of the Rajasthan Atomic Power Project (RAPP) is expected to start commercial operation towards the end of 1973. second unit of RAPP is expected to attain critically in 1975. Commercial supply from this unit will be commenced some months after criticality.

(b) A working group appointed by the Atomic Energy Commission to evaluate the concept of nuclear powered agro-industrial complexes has submitted its report. Among the projects studied by the working group are those relating to the establishment of such complexes in the Gangetic plain as well as in the Kutch-Saurashtra Further detailed studies on these projects are in progress.
