The disclosure, however, of information which Government have in its possession or the details of what is done to counter the activities of foreign intelligence organisations, including the CIA, will not serve any public interest.

(b) whether the Indian Institute of Management, Calcutta have been paid a sum far exceeding the original contract; and if so, the reasons therefor?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY (SHRI C. SUBRAMANIAM): (a) Yes, Sir. The Indian Institute of Management, Calcutta was entrusted with the task of designing and implementation of a computer based information system for the Directorate General of Technical Development.

(b) No, Sir. The Indian Institute of Management, Calcutta has been paid a sum of Rs. 5 lakhs as per terms of the contract. Besides, an *ad hoc* payment of Rs. 1,80,000 was made to them for the additional work done by them.
