(b) if so, Government's reaction thereto?

THE MINISTER OF STATE (DEFENCE PRODUCTION) IN THE MINISTRY OF DEFENCE (SHRI VIDYA CHARAN SHUKLA): (a) Yes, Sir.

(b) The observations stated to have been made by Shri P. V. R. Rao have been looked into by the Government. The manufacture of this aircraft was decided upon after Government considered all the offers on their merits in 1959 based on the recommendations of a Committee of experts. There was no question of any divided council and misplaced loyalties, in this matter. Regarding his alleged observation about the lapses in handling this project, it may be stated that this project was a subject matter of detailed examination by the Public Accounts Committee, (vide their 37th Report-1964-65) and the Committee on Public Undertakings (Eighth Report—1967-68). These observations had been noted by the Government.
