(b) if so, Government's reaction in this regard?

THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): (a) Yes, Sir.

(b) As far as the question of Pak POWs is concerned, the Government of India have taken serveral initiatives for an early solution of the question. It is only Pakistan Government's attitude which is responsible for delaying their early return. A new generous offer has now been made to Pakistan through the Indo-Bangladesh Joint Declaration, of April 17, 1973. In the meantime, Pak POWs continue to receive the most humane treatment in India.

COMPLETION OF MINI-SLEEL PLANT IN ORISSA

The Corporation are getting feasibility report prepared and technological matching tests of iron ores and coal conducted before implementing the scheme.

(c) the Corporation, who hold a letter of intent are a wholly state-owned undertaking.
