#### RAILWAY SYSTEM IN BIHAR

- (a) whether it is a fact that the route kilometreage per thousand square kilometres for Bihar is less than that for the whole of India; if so, the reasons therefor; and
- (b) what steps Government propose to take to construct more railway lines in Bihar?

THE MINISTER OF RAILWAYS (SHRI L. N. MISHRA) (a) No. Sir. The Railway route kilometreage per thousand square kilometres ©f area for Bihar State is 30.89 as against 18.86 for the whole of India.

(b) With the object of providing additional rail transport facilities and for the general development of the area, proposals for a few new lines and restorations in

Bihar are under consideration. Feasibility studies and traffic appreciations for some of these have been completed and the reports are under examination. For some others such studies are in progress. A final decision in respect of each of these projects will he taken after the respective reports are examined from all angles by the Ministry of Railways.

## **STATEMENT**

The demand for High Speed DieseT (HSD) and Light Diesel Oil (LDO) has been registering a progressive increase for the last several years. The actual consumption of these products during the last five years and the estimated demand for the current year is given below:-

Against the total anticipated demand of 52.91 lakhs and 14.61 lakh tonnes of HSD and LDO in 1973, indigenous production is expected to be about 48.30 lakh and 10.86 lakh tonnes respectively. The deficit requirements of 4.61 lakh tonnes of HSD and 3.75 lakh tonnes of LDO are being *met* from imports.

विधि, न्याय और कम्पनी कार्य मंत्री (श्री एव० आर० गोखले): (क) 1972 में विवियन बोम आयोग की रिपोर्ट के मुझावों पर आधारित माहू जैन तथा डालमिया जैन समूह के कार्यों में कोई जांच सम्पन्न तहीं की है। सरकार ने, तथापि, माहू जैन और डाजमिया जैन समूह के समस्त बड़े श्रीद्योगिक गृहों, जिनके उनकी कम्पनिया मिम्मलित हैं, की लेखा-बहियों के निरोक्षण का प्रशामनिक निर्णय लिया है।

(ख) 1971 और 1972 के मध्य, साह जैन समृह से सम्बन्धित 80 कस्पनियों की लेखा बहियों के निरीक्षण के आदेण दिये गये थे। ग्रभी तक 58 कम्पनियों की रिपौटं प्रास्त हुई है, जिनमें से 23 के सम्बन्ध में क्षेत्रीय अधिकारियों को सम्बन्धित कम्पनियों के स्पष्टीकरण प्राप्त किये जाने के लिए अनुदेश प्रेषित किये गये हैं। प्रत्येक मामले में अन्तिम कार्यवाही कम्पनी के स्पष्टीकारण और क्षेत्रीय अधिकारियों की रिपार्ट पर निर्भर करेगी।

t[THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI H. R. GOKHALE): (a) In 1972 no enquiry has been conducted in the affairs of Sahu Jain and Dalmia Jain Group of Companies based on tile recommendations of the Vivian Bose Commission's Report. The Government have, however, taken an administrative decision to inspect the books of account of all larger industrial houses which include the companies of Sahu Jain & Dalmia Jain Group.

(b) During 1971 and 1972 books of account of 80 companies belonging to the Sahu Jain Group were ordered to be inspected. So far reports on 58 companies have been received, out of which instructions have been issued in respect of 23 companies to the field officers for obtaining explanation of the concerned companies. Final action in each case will depend on the Company's explanation and the report of the field officers.]
