THE MINISTER OF TOURISM AND AVIATION (DR. KARAN CIVIL SINGH): (a) and (b) No Sir. However, several schemes for improvement to aerodromes in Gujarat State have been sanctioned. The terminal buildings at Ahmedabad. Bhavnagar, Bhui and Rajkot aerodromes are being expanded and improved. The construction of a new passenger shed at Keshod is expected to commence shortly. The runway at Keshod aerodrome is being developed for HS-748 services and similar development of the runway at Porbandar aerodrome is expected commence shortly. The taxi-track and apron at Ahmedabad aerodrome are being strengthened.

# DEVELOPMENT OF HOTEL AND WINTER SPORTS RESORT AT GUL-MARG

ment and the Indian Tourism Development Corporation in developing hotel and winter sports resort at Gulmarg; and

(b) how many tourists visited Gulmarg during 1972-73 winter motivated by ITDC-IAC package programme?

MINISTER OF TOURISM AND THE CIVIL AVIATION (DR. KARAN SINGH): (a) For the development of winter sports at Gulmarg the expenditure incurred by the Central Government from 1-4-1966 to 31-3-1973 is estimated at Rs. 118.84 lakhs. The State Government has so far spent about Rs. 36 lakhs. No expenditure has yet been incurred by the India Tourism Development Corporation on hotel construction in Gulmarg.

(b) A total of 5,705 tourists visited Gulmarg during 1972-73 winter season—4,398 domestic tourists and 1,307 foreign tourists including foreigners resident in India. Of these 59 tourists took advantage of the 6-day package tour for winter sports at Gulmarg sponsored by the Department of Tourism, Indian Airlines and a consortium of travel agents. In addition, of course, tens of thousands of tourists visit Gulmarg during the summer.
