**THE MINISTER OF SHIPPING AND TRANSPORT (SHRI RAJ BAHADUR):**

(a) to (d) In response to a Shipping and Transport Ministry's general circular letter inviting proposals for additions to the National Highway System during the 5th Plan period, all the State Governments/ Union Territories, including Madhya Pradesh have submitted proposals for the declaration of certain roads as National Highways. All these proposals will have to be considered while finalising proposals for the Fifth Plan keeping in view the funds which might be made available for the purpose in that Plan, the *inter-se* priorities of these proposals on an all-India basis, and the criteria laid down for classification of roads as National Highways. However, since the formulation of the Fifth Plan is in a preparatory stage, it is not possible at present to indicate any details.

SHER SINGH) :** (a) Sales Assistants in Delhi Milk Scheme who are Class IV employees are not eligible for promotion to Class III posts in D.M.S. Class IV employees including Sales Assistants can, however, be considered for direct recruitment as departmental candidates to Class III posts in D.M.S. provided they fulfil the prescribed educational, age and other qualifications. Five such Sales Assistants have been appointed to Class III posts so far
