## PROMOTION OF TEACHERS IN DELHI

- 612. SHRI NAGESHWAR PRASAD SHAHI: Will the Minister of EDUCA TION AND SOCIAL WELFARE AND CULTURE be pleased to state:
- (a) whether it is a fact that the High Court of Delhi in its decision on February 21, 1973 has vacated the stay order regard ing promotions from T.G.T. to P.G.T. and other categories of teachers of Union Territory of Delhi;
- (b) if so, why so long eligibility tests for promotion of teachers have not been implemented by Delhi Administration; and
- (c) whether there is any move for promoting the teachers shown in the eligibility tests list?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION, SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) and (b) No, Sir. The stay order was slightly modified allowing the Delhi Administration to make ad-hoc promotions if considered essential. However, the Delhi Administration did not consider it essential to make *ad-hoc* promotions at that stage, since the students of XI were going for final examinations in early March, 1973.

(c) Yes, Sir.

Final decision in regard to the locations of additional shipyards will be taken or receipt of the report of the Techno-Economic Working Group.
