(a) whether it is a fact that some of the canalising agencies like the Small Industries

Development Corporations are charging

High Com'rnission on raw materials;

(b) if so, whether it has been done on the advice of any Committee;

(c) whether this would adversely effect the working of small scale units in the country; and

(d) what measures Government propose *to* take to eliminate this discrimination against the small scale sector?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVE-LOPMENT (SHRI Z. R. ANSARI) : (a) A number of representations have been received by this Ministry wherein it has been requested that the Commission charged by State Small Industries Corporations, M. M. T. C. and S. T. C. etc. on steel and other imported raw materials may be reduced.

(b) The prices of imported raw materials canalised through STC, MMTC etc. are determined by a Committee in the Ministry of Commerce.

(c) High prices of raw materials are one of the factors which adversely affect the working of small scale units.

(d) A Committee was appointed by Ministry of Steel and Mines to go into this question. Their report is under consideration of the Ministry of Steel and Mines.
