Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state :

(a) the base of allocation of raw material to Small Scale Industrial units; and

(b) whether the criteria is the same or different from large scale units ?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT (SHRI Z. R. ANSARI) :

(a) *Indigenous raw materials* : Allocation of indigenous raw materials to individual small scale industrial units is made by the State Director of Industries according to their own priorities keeping in view the requirements and overall availability of the allocation of various categories of indigenous raw materials.

Imported raw materials : Allocation of imported raw materials is made according to the provisions contained in the import trade control policy for the relevant year. According to the current import policy new units in the priority sector get imported raw materials on the basis of their assessed capacity on single shift and the units in the non-priority sector (existing and new units) on the basis of the value of Machinery installed. Existing units in the priority industries get allocation of raw materials on the basis of past consumption. If the allocation falls short of their assessed capacity they have option to be treated as new units.

(b) The criterion for allocation of indigenous imported raw materials to the large scale units is made on the basis of their licensed/rated capacity.
