monies are charged from the prospective visitors here, but the tickets are provided free by the Russian or other airlines and in this way that money which is collected here is used for party purposes? If attention has been drawn to this and other methods as indicated by him, can you assure the House that you would look into all those methods and satisfy the House, also about your findings?

SHRI K. C. PANT: My attention has not been drawn to it in the past, but it has been drawn by my honourable friend now. Therefore, at this stage, I cannot say anything about it.

DR. BHAI MAHAVIR: No, no, you can promise to look into all these.

SHRI LOKANATH MISRA: The Deputy Finance Minister, Mrs. Sushila Rohatgi, assured this House that the Government would look into it. I do not know whether it has been confined to the Finance Ministry. or else, it should have been conveyed to the Home Ministry and to the Prime Minister because this is a matter of great importance.

SHRI K. C. PANT: This takes the load off my shoulder. The Deputy Minister of Finance will doubtless inform the honourable Member about it.

DR BHAI MAHAVIR No, that increases the burden on your shoulders, otherwise, it would appear that the Government is taking a very casual attitude on this very serious question. I have pointed out certain charges. The Minister can say that he would look into them Why does he not say that? He says he cannot say anything at this stage.

SHRI LOKANATH MISRA: Sir, why does not the Prime Minister say anything? This is a matter of vital importance. The Prime Minister should say something on

SHRI K. C. PANT · According to the honourable Member himself, the matter is being looked into by the Government and from another Ministry they said that they are looking into it The honourable Member should be satisfied now.

SHRI LOKANATH MISRA: As head of the Government if the Prime Minister says a word about this that the Government would look into it, it would satisfy us.

DR. BHAI MAHAVIR: The Home Minister does not know it and the Finance Minister is looking into it. He can say that he would look into it and that if there is anything wrong, it will be corrected.
