

**NEW INDUSTRIES IN THE BACKWARD  
AREAS**

**\*229. SHRI K.B. CHETTRI :**

**DR. R.K. CHAKRABARTI :**

Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state :

(a) whether there is any plan to start consumer goods industries in the backward districts;

(b) if so, whether a steady supply of raw materials as well as marketing facilities will be available to these industries from the Government trading bodies and organisations?

**THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY (SHRI C. SUBRAMANIAM):** (a) and (b) A statement is laid on the Table of the House.

**STATEMENT**

Though there is no specific plan for starting industries for the manufacture of consumer goods in backward areas, Government have formulated the following incentive schemes for encouraging the growth of industries in selected backward areas, (i) Schemes for concessional finance from financial institutions, (ii) 10% Central Outright Subsidy Scheme and, (iii) Transport Subsidy Scheme. These schemes are open to all industries, either in the public or private sector including industrial units manufacturing consumer goods.

The import policy for raw materials, components and spares for small scale units in selected backward areas already provides for 2/3rd of the entitlement of the individual units in free foreign exchange and the balance from U.K. credit. This provision is substantially more liberal than available to similar units in other areas.

**FOREIGN OWNED PLANTATIONS IN KERALA**

**THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K.C. PANT):** (a) and (b) No, Sir. The proposal is still under the consideration of Government
