

**DAMAGE TO ORE HANDLING PLANT AT PARADEEP PORT**

**WORKERS UNEMPLOYED**

(a) whether it is a fact that due to closure of some 200 small scale electric bulb making industries in West Bengal, 32,000 workers have been rendered unemployed; and

(b) if so, what steps have been taken to save these small scale lamp making industries in West Bengal ?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR AND REHABILITATION (SHRI G. VENKATSWAMY): (a) and (b) The matter falls essentially in the State sphere.

**SHORTAGE OF MOTOR CHASIS IN THE COUNTRY**

827. SHRI SARDARAMJADALI: Will the Minister of HEAVY INDUSTRY be pleased to state:

(a) whether Government are aware of the shortage of chasis of heavy trucks and other public carriage vehicles in the country; and

(b) if so, what steps are being taken to solve the problem?

THE MINISTER OF HEAVY INDUSTRY (SHRI T.A. PAI): (a) Yes, Sir. The shortage relates mainly to vehicles of two popular makes for which customers have to wait for about 18 to 21 years.

(b) Government have approved the schemes of the manufacturers of these two makes for expanding their production capacity. A third unit has also been permitted to expand. Government have also approved four new schemes envisaging a total capacity of 54,000 vehicles per annum.
